

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$595,982.05 which includes an amount to be raised by taxation of \$570,277.05 and Total Appropriations of \$595,982.05; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 9, 2020 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2021 and ending December 31, 2021 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The total budget is increasing from \$584,734 in 2020 to \$595,982.05 in 2021. The total budget in 2021 was increased by the 2% cap increase of \$11,248.05 and by the increase a ratable valuation of \$67.47.

A. Commissioners was increased by \$4,300 to reflect Resolution #19-003, Establishing Commissioner Compensation that was approved on February 13, 2019. B. Salaries & Wages was increased by \$9,100 to reflect the appointment of both a Fire Official and Fire Inspector on March 11, 2020 per Resolution #20-010 and Resolution #20-011.
