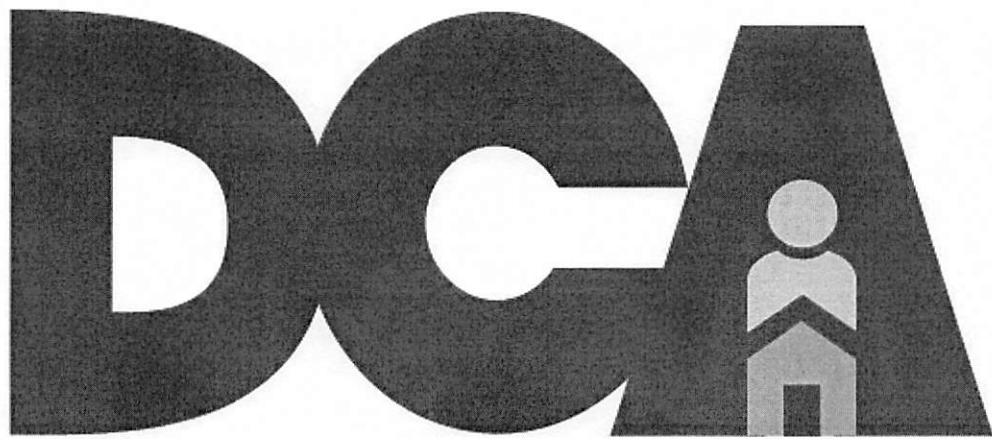

WHEREAS, the Annual Budget for Washington Township FD No. 1 (Warren) (the 'Fire District') for the fiscal year beginning January 1, 2026 and ending December 31, 2026 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 10, 2025; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,033,621.17 which includes an amount to be raised by taxation of \$632,721.17 and Total Appropriations of \$1,033,621.17; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 10, 2025 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 14, 2026.

WHEREAS, the Annual Budget for the Washington Township FD No. 1 (Warren) (the 'Fire District') for the fiscal year beginning January 1, 2026 and ending December 31, 2026 has been presented for adoption before the Board of Commissioners of the Fire District at its open public meeting of January 14, 2026; and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District at an open public meeting held on January 14, 2026 that the Annual Budget of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby adopted and, shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$1,033,621.17, which includes amount to be raised by taxation of \$632,721.17, and Total Appropriations of \$1,033,621.17; and

The total budget is increasing from \$750,085.07 in 2025 to \$1,033,621.17 in 2026. The total budget in 2026 was increased by the 2% cap increase of \$12,387.60, the increase in ratable valuation of \$953.50 and increase of \$400,000 due to the approval to purchase a Fire Apparatus.

A. Salary & Wages were decreased by \$50,327 to reflect the elimination of one Firehouse Caretaker. B. Fire Hydrants were increased by \$18,838 due to the increase of costs by NJ American Water Company. C. Salary & Wages were decreased by \$28,802 due to eliminating the position of the Fire Official. The Township has now taken on the responsibility of the Fire Official. D. Supplies were decreased by \$7,405 due to eliminating the position of the Fire Official. E. Total Capital Appropriations were increased by \$339,430. Increased by \$400,000 due to the approval to purchase a Fire Apparatus, increased by \$44,430 due to additional funds to reserve for future capital outlays and decreased by \$105,000 due to purchase a Fire Chief's vehicle in 2025. F. Total Revenues Offset with Appropriations were decreased by \$24,805 due to the elimination of the Fire Official and transferring the duties of the Fire Official to the Township.
